The name on IDs must agree with the name on the badge being issued unless accompanied by official name change document or endorsement. All documents must be valid and unexpired. Only original documents or copies certified by the original issuing authority may be used.

#### Acceptable Photo IDs

Previously issued **Lockheed Martin Employee or Non-Employee photo ID badge or Other Company or Student photo ID.**



#### US Federal, State or Local Government issued Photo ID

Any Photo ID issued by a federal, state or local government of a U.S. state, jurisdiction or territory (Puerto Rico, U.S. Virgin Islands, Northern Mariana Islands, American Samoa, Swain's Island, Guam)



### LIST C - ACCEPTABLE U.S. PERSON STATUS VERIFICATION

#### US Citizen (Issue LM Badge with Blue Color Bar)

##### Security Clearance

Must be verified in JPAS  
Capture Level of Clearance and Date of Investigation in Proofing Agreement Form

##### US Birth Certificate

Issued by a U.S. state, jurisdiction or territory (Puerto Rico, U.S. V.I., North Mariana Islands, American Samoa, Swain's Island, Guam)



**Note: Puerto Rican birth certificates issued before July 1, 2010 are not acceptable.**
